### Section 4: First aid measures

#### Description of necessary first aid measures:

**Eye Contact:** Immediately flush the eyes with plenty of water, occasionally lifting the upper and the lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least ten minutes. Get medical attention.

**Inhalation:** Remove the victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing or if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth to mouth resuscitation. Get medical attention if adverse health effects persist or are severe. If unconscious, place in the recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as collar, tie, belt or waistband.

**Skin Contact:** Flush the contaminated skin with plenty of water. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing it or wear gloves. Continue to rinse for at least ten minutes. Get medical attention in the event of any complaints or symptoms, avoid further exposure. Wash clothing before reuse, clean shoes thoroughly before reuse.

**Ingestion:** Wash out mouth with water, Remove dentures if any. Remove victim to fresh air and keep at rest in position comfortable for breathing. If the material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low, so as to prevent the vomit entering the lungs. Get medical attention if adverse health effects persist or are severe. Never give anything by mouth to an unconscious person. #### **5.2 Special hazards arising from the substance or mixture:**

##### **Hazards from the substance or mixture:**

Flammable liquid and vapour. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. The vapour/gas is heavier than air and will spread along the ground. Vapours may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. Runoff to sewer may create fire or explosion hazard.

#### **6.3 Methods and material for containment and cleanup:**

Small Spill:

Stop leak, if without risk. Move containers from the spill area. Dilute with water and mop up if water soluble, alternatively or if water insoluble, absorb with a dry inert material and place in an appropriate disposal container. Dispose of via a licensed disposal contractor.

#### Large Spill:

Stop leak if without risk. Move containers from spill area. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with combustible, absorbent material e.g. sand, earth, vermiculite, or diatomaceous earth and place in a suitable container for disposal according to local regulations. Dispose of via a licensed waste disposal contractor. Contaminated absorbent materials may pose the same or similar hazards as the spilt products.

All spills must be reported if required under local regulations, and all waste disposal must comply to any and all relevant, local, national and international regulations.

##### **7.1. Precautions for safe handling:**

###### **Protective measures:**

Put on appropriate personal protective equipment (see section 8). Persons with a history of skin sensitisation problems should not be employed in any process in which this product is used. Do not get in the eyes or on skin or clothing. Do not ingest. Avoid breathing vapour or mist. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not re-use container.

Advice on general occupational hygiene:

Shield UV light sources. Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well ventilated area, away from incompatible materials(See Section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. #### **Appropriate engineering controls:**
